Application for Individual Membership of the ITC

Individual membership in the International Test Commission (ITC) is open to anyone with an interest in educational and psychological testing.

Individual members:

- Have free access to the ITC's Learning Centre website www.itc-learning.net where they can engage in a range of learning projects for CPD or for qualification purposes. Members get discounts on the costs of ITC Assessment where external assessors are required for qualification purposes.
- Get a login to access the members area of the ITC website www.intestcom.org, where they can find records of past General Meetings, download draft guidelines and other materials. All Individual Members are invited to the biennial General Meeting of the ITC held at the biennial conferences.

Individual members receive -

- The *ITC Newsletter TESTING INTERNATIONAL* (twice a year),
- The ITC journal, *International Journal of Testing* (issued in four parts each year).
- The ITC President's *Progress Reports* (twice a year),

In addition -

- Individual members are encouraged to participate fully in ITC projects, publications, symposia at national and international meetings and conferences, and other activities.
- Receive a reduction in registration fees for attendance at ITC sponsored conferences, which is also inclusive of the membership fee.

Individual Member Annual Fees

If you attend the ITC Biennial Conference, your membership is covered for two years by your conference registration fee.

Otherwise, the Standard Individual Member Fee is **£35.00** per year.

- However, if you pay for two years in advance, you will get a discount and the price for two years is only **£60.00**.
- Members are invoiced on the nearest Quarter Day to the anniversary of their taking out membership (Note the Quarter Days are 1st January, 1st April, 1st of July, and 1st of October).
- Fees are accepted by online Stripe payment either with a credit card or on a PayPal account.
- We regret that we are unable to accept payments in cash or by cheque.
